She stated that if the budget is cut any more than it has been that they will be in trouble the next few years.
- 2. Kim Lindstrom, of 654 Woodtick Road** came forward to express her support of the Board of Education's proposed budget. She stated the faculty works very hard to maintain a lean budget and they do not spend frivolously. She added that as an involved parent, she trusts that the teachers are submitting budgets for items that are necessary, and there is no other organization that knows what her child needs everyday.
